Dear Board Members,

We would like to extend our deepest appreciation for your service, contributions, and unwavering support over the past four years. Your commitment has been instrumental in the success of the Global Fund partnership, driving our swift response to the Covid-19 pandemic, spearheading unprecedented replenishments, the expansion of effective grants and, thereby, saving an increasing number of lives.

Since the start of the Covid-19 outbreak in 2020, the Global Fund allocated US\$5 billion (as of May 2023) to assist countries in combating the pandemic, sustaining crucial HIV, TB, and malaria services, and strengthening health systems. Despite the impact of the virus on the Covid-19 pandemic on HIV, TB, and malaria in low- and middle-income countries, the prompt actions by the Global Fund averted potentially more severe consequences.

The effectiveness of Global Fund interventions has been demonstrated across all three disease areas, as confirmed by the Global Fund's Results Report 2022. The Results report emphasizes how our partnership has empowered countries and communities in managing the pandemic and persisting in the fight against HIV, TB, and malaria. Since our inception in 2002, we have cumulatively saved 50 million lives.

These remarkable responses and results serve as a powerful reminder of why we strive to serve the health needs of people and communities, and to end AIDS, TB, and malaria. Once again, we express our profound gratitude to our board members for your support and dedication.

This report presents the Board and Board Leadership's work from July 2022 to May 2023, with a focus on the replenishment, preparation for strategy implementation, and governance and transition.

Our primary role as Board Leadership has been managing the Board's affairs, including ensuring the Board is organized properly, functions effectively, and meets its obligations and responsibilities. During 2022-2023, we organized and facilitated the Board discussions outlined in this report (and detailed in the November 2022 and May 2023 Board Reports, linked below).

The Board's decisions, as shown in Annex 2, are organized around its six core functions (as set out in the Bylaws), namely Strategy Development, Governance Oversight, Commitment to Financial Resources, Assessment of Organizational Performance, Risk Management, Partnership Engagement, Resource Mobilization, and Advocacy.

We were also actively involved in advocacy for the Global Fund replenishment (as summarised in Annex 1). We would like to thank the External Relations and Communication Department as well as the Governance Team for their support with these engagements.

1. Record Replenishment

The most significant achievement of the past year was the Seventh Replenishment, culminating in a record total of US\$15.7 billion. This success, amidst challenging global economic conditions, is testament to our collective dedication to combating HIV, Tuberculosis, and Malaria.

Our gratitude extends to each Board member, and to all public and private donors, with special acknowledgment of the implementer governments that pledged as donors themselves. We also wish to

acknowledge our advocates from civil society and communities who have relentlessly supported the Global Fund. Your collective efforts highlight the potency of our partnership and its capacity to effect meaningful change.

Following the successful Replenishment outcome, the Board approved investments totalling US\$13.7 billion at our November Board meeting. This will assist over 120 countries in their battle against the three diseases and to bolster their health systems over the next three years.

We also thank the Board and committees for their understanding and flexibility in approving these investments, which stand as a fine example of the strength and trust within our governance bodies. Prior to the November Board meeting, there was uncertainty about the final quantum of resources for the Sources of Funds, and this necessitated agile decision-making by committees and the Board. We commend the Secretariat for providing clear and transparent information on the evolving financial data.

2. Implementing the New Strategy

In November 2021, the Board approved a new, ambitious Strategy that places people at the centre of the fight against HIV, TB, and malaria. Recognising lessons from the past and challenges for the future, the new Strategy includes:

- 1. A stronger focus on prevention across HIV, TB, and malaria, emphasizing the need to reduce new infections among vulnerable populations to end these pandemics.
- 2. Emphasis on integrated, people-centred healthcare services that address multiple diseases, holistic needs, and promote overall health and well-being, moving beyond the silos of individual diseases.
- 3. Systematic support for developing and integrating community health systems, recognizing their vital role in combating the three diseases and reinforcing healthcare system resilience and sustainability.
- 4. Empowerment and inclusion of communities affected by the diseases, putting them at the centre of the Global Fund's efforts, and working to eliminate barriers to their participation and leadership.
- 5. Intensified efforts to address inequities, human rights, and gender-related barriers, scaling up existing activities, learning from experiences, and increasing ambition levels.
- 6. Increased focus on programmatic and financial sustainability, to ensure that progress can withstand shocks and reversals, and the momentum can be sustained.
- 7. An emphasis on accelerating equitable access to and deployment of healthcare innovations, working to quickly address bottlenecks to those most in need.
- 8. Greater reliance on data-driven decision-making, through investment in systems and capabilities for rapid generation, analysis, and use of high-quality, disaggregated data.

- 9. Explicit recognition of the Global Fund's role in pandemic preparedness and response, considering the secondary impact of pandemics on HIV, TB, and malaria, and defining roles and responsibilities in collaboration with partners.
- 10. Clear delineation of roles and accountabilities of Global Fund partners across all aspects of the Strategy, to ensure mutual accountability in its delivery.

Understandably, the Board expressed enthusiasm for visibility and discussion of Strategy implementation, as part of our oversight of strategy and organisational performance. This is being taken up through a series of committee and Board discussions, both on key decisions and thematic topics, as well as planned evaluations and discussions of strategic performance reports. So far, this has included:

- Approval of a new monitoring and evaluation framework, including key performance indicators, as a crucial tool to measure investment impacts and rigorously track and report performance.
- Thematic discussion and strong commitment to gender equality, human rights, and community leadership—critical components for the new Strategy to effectively combat the three diseases.
- Discussion of the strengths of the Global Fund partnership in shaping global health product markets, highlighting the need to accelerate equitable access to innovative medical products.
- Approval to continue offering the Global Fund's online procurement platform, wambo.org, for non-Global Fund-financed orders by governments and development organizations.
- Extension of the COVID-19 Response Mechanism (C19RM) until the end of 2025, enabling countries to utilize remaining funds based on their evolving priorities and to strengthen health systems.
- Recognition of the Global Fund's pivotal role in combating pandemics, engaging in dialogue on how the Global Fund can best contribute to the pandemic preparedness agenda alongside the World Health Organization and the World Bank.
- Careful oversight of risks, including approving increasing risk appetite for malaria interventions while also maintaining vigilance against TB.

3. Governance

Governance improvement, and trust-building, are ongoing endeavours that involve us all.

We express deep gratitude to the Ethics and Governance Committee, the Audit and Finance Committee and the Strategy Committee for their respective commitments to governance, financial oversight, and strategic guidance, all integral to the Board's function and the governance of the Global Fund. Likewise, we are grateful to the Technical Review Panel (TRP), Independent Evaluation Panel (IEP), Country Coordinating Mechanisms (CCMs), and our grant implementors, whose unwavering commitment and expertise drive the Global Fund's success. We sincerely appreciate the Ethics Office and Office of the Inspector General for their vigilant work in upholding strict ethical standards through implementing conduct codes, delivering training, and conducting investigations and audits. And we underscore that the ongoing vigilance and further strengthening of safeguards against any form of exploitation or abuse are imperative for the Global Fund.

Special acknowledgment goes to Executive Director Peter Sands, for his strategic leadership, and to Inspector General Tracy Staines, for her diligent assurance of systems and accountability. We also extend our thanks to the Secretariat, the OIG staff, and the Governance Team within the Legal and Governance Department for their invaluable support.

To each of you, we extend our deepest gratitude. Your commitment goes beyond invaluable—it is lifesaving.

4. Board Leadership Transition

During the Board Leadership transition in Ha Noi, we welcomed our new Vice-Chair, Bience Gawanas, and acknowledged the crucial function of the Coordinating Group (CG). As discussed in the CG's report to the Board (linked below), the CG will continue to coordinate committee work plans, discuss cross-cutting issues (such as risk, KPIs and pandemic preparedness) and ensure agendas that align with the 2023-2028 Strategy.

Our parting advice to the Board is to remain vigilant in the face of new and unfolding challenges from climate change, conflict, economic and social disruptions, and encroachment on human rights. It is imperative to reinvigorate both political and technical leadership, so we can address these challenges thoughtfully and effectively.

We are reassured that the Global Fund partnership's collective resilience and adaptability have always been the bedrock of our accomplishments, and they will continue to serve well in the coming years.
